RAYS REPORT #11: HUGE SUCCESS OFF THE ICE!

Corpus Christi ended their five game losing streak but saw their winless streak reach six games after gaining just one point of a possible four from the Texas Tornado last week at the American Bank Center. All was not lost though as the team made big news off the ice with a major donation to the American Cancer Society as part of Pink In the Rink Night presented by CC Disposal and Radiology and Imaging. The 'Rays are off this week, but that doesn't mean there aren't some great ways to follow the guys in the bye week. Check out where the team will be.

GAME #1: Corpus Christi 3-6 Texas: The Corpus Christi IceRays had a 2-1 lead in the second period, but the Texas Tornado stormed back to double up the 'Rays, 6-3, at the American Bank Center on Thursday night. Colton Saucerman had a two-point night for the IceRays while Michael Benedict tallied his team-leading 21st goal of the year.

GAME #2: Corpus Christi 3-4 Texas (OT): Jason Souva scored twice including a third period goal to force overtime, but the Corpus Christi IceRays fell to the Texas Tornado, 4-3 in the extra frame on Pink in the Rink Night on Friday at the American Bank Center. Beau Walker recorded his 50th point in the overtime loss.

RISE AND SHINE WALK 2011: The team has a rare weekend off, but that doesn't mean there isn't still work to be done! Members of the IceRays and staff will be involved in the Rise School of Corpus Christi's "Rise and Shine Walk 2011" to be held on Saturday February 19, 2011 at Whataburger Field, home of the Corpus Christi Hooks. The team will be selling raffle tickets for the custom 2011 Harley-Davidson motorcycle for \$10 each. All proceeds benefit the Rise School of Corpus Christi with the bike raffled off on PACK THE HOUSE night on March 25th. PINK IN THE RINK DRAWS NATIONAL ATTENTION: The IceRays' third annual Pink in the Rink Night drew national attention for the team's tremendous donation to the American Cancer Society. Through a silent auction, donations, and a post-game jersey auction, the team raised \$24,250 for the ACS. Over the past three seasons, the team has averaged a donation of \$36,000 for breast cancer research and awareness. Brandon Marshall's jersey went for the most after the game as his pink sweater fetched a \$1,900 donation. AROUND THE SOUTH DIVISION: Corpus Christi currently sits fifth in the South Division with a record of 17-27-3 (36 points).

PLAYOFF PICTURE: Corpus Christi is still alive in the playoff hunt, but will need to play their best hockey of the season down the stretch to overtake the Wichita Falls Wildcats for the final playoff spot in the South. Currently, the IceRays trail their first-half rivals by nine (9) points with 11 games remaining for Corpus Christi. Wichita Falls has 14 games left on their schedule, including two at home against Texas on Friday and Saturday. The IceRays were 5-6-1 against Wichita Falls this season, playing all the contests during the first half of the season.

SOUVA'S SIZZLING... Jason Souva has found his offensive game over the past week, tallying four goals in his last five games with all of his output coming in two separate two-goal games. Souva had three goals coming into the week. He would have had five goals in five games, but one of his would-be goals was waived off due to an inadvertent whistle.

20 SUITS BENNY WELL... Michael Benedict scored in third period on February 4th in Topeka to become the first player in the NAHL IceRays' history to reach the 20-goal plateau.

HALFWAY TO 100... Beau Walker became the first player this season to reach 50 points on February 11th with a first period assist.

ON THEIR BEST BEHAVIOR... The IceRays collected just 10 penalty minutes in the game on February 10th v. Texas, their fewest of the season. Texas had four penalty minutes. Combined with Corpus Christi's 10, the 14 penalty minutes were the fewest combined PIMS in an IceRays game this season.

ON THEIR BEST BEHAVIOR PT. 2... Corpus Christi continued their clean play the following night on February 11th matching their season-low with 10 penalty minutes.

RAYS ROBBED... Corpus Christi appeared to have tied Friday, February 6th's game against Topeka with 16 seconds remaining in the third period, but Jason Souva's apparent goal was waived off after referee Steven Thomson deemed the puck was covered.

SAUCE'S SEASON-HIGH... Colton Saucerman tallied four points against New Mexico on January 14th. It was a team-high for a single-game this season. On the night, "Sauce" tallied two goals and two assists.

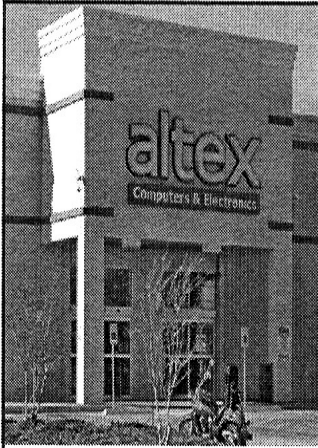
STLOUKAL STRIKES AT THE BUZZER... Petr Stloukal tallied as the 3rd period buzzer sounded in the team's 6-3 loss at Amarillo on Sunday January 29th. It was the latest goal scored by an IceRays player this season. The Czech Republic native has five goals and six assists for 11 points in 15 games played for Corpus Christi since being acquired from the Chicago Steel (USHL).

POWER OUTAGE... Corpus Christi was shutout for the seventh time this season in a 6-0 loss to Topeka on Saturday, February 5th.

FINE JEWELRY OUTLET PLAYER OF THE MONTH... Beau Walker received the Fine Jewelry Outlet Player of the Month award for the month of January. During the month, he collected five goals and five assists for 10 points. Walker has started February on a fast note as well with seven points in five games.

ONE OF TWO OVER 3,000... The IceRays are one of two teams (Wenatchee) who have averaged over 3,000 fans per game in attendance. Over 70,000 fans have watched the team at the American Bank Center in their inaugural season in the NAHL.

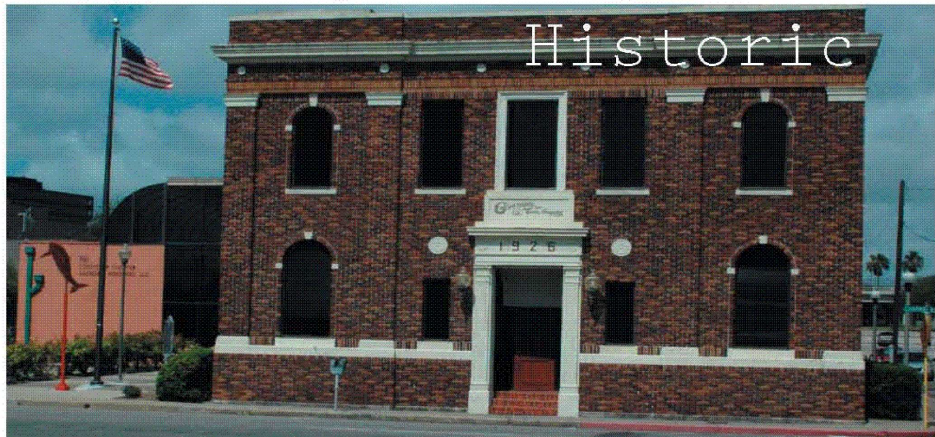

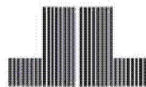
