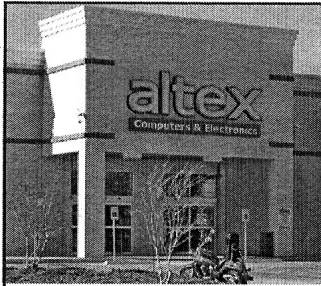
mentorship," say's Commissioner Canales."
