FROM THE EDITOR

DON'T MESS WITH TEXAS!

A couple of weeks ago we went for an extended weekend to the Texas Hill Country, or as many refer to it "Gods' Country" to take advantage of the recent rains and float the Frio River. For those of you that can get away and enjoy "tubing the river", the Frio River is flowing very well right now, better than it has in years according to the locals. It was a bit chilly sometimes in the shade since the temperature did not rise above the 90 degree mark but for the most part, very enjoyable.

There are several ways to enjoy a trip down the Frio, each offering its advantages and disadvantages. First is the conventional way by renting tubes to float down the river on your back. This method allows you to enjoy the company of your friends and family by traveling in a pack at a slow and sometimes negligible pace. Of course you always have to rent the extra tube reserved for an ice chest full of snacks and beverages tied to the tube of the most responsible party (usually the wife). Tubing on your back allows you to take in the spectacular scenery as you lazily float by sipping your favorite beverage. However, this can get uncomfortable after a while especially if you forgot to pack the sun screen and you had better remember to lift up over the rapids or bash your backside on a hidden boulder just under the surface. This can be very painful and at times may draw blood. Of course there is the tube rash you get from paddling in those spots of the river that seem to stand still.

Secondly, my preferred method, is to don our snorkel and fins and explore the underwater world of the river that is teeming with a variety of fish. This gives us a completely different perspective on the river as it comes alive with turtles, catfish, bass, perch and minnows, all in their natural habitat. It's like being at the Texas State Aquarium but in the tank. For those adrenaline junkies like me, shooting the rapids head first with

snorkel and fins is a rush that tests your agility and reflexes. Watching the river bottom pass inches below as you speed by at several miles an hour keeping an ever watchful eye ahead to avoid the obstacles that make the river sing and

run is a phenomenal experience. Of course an occasional bump or bruise will occur but it is well worth the sense of individual accomplishment and the need for speed that some crave. However, out of the water, fins are not the most efficient way to traverse the rocky terrain, so you have to take them off and replace them with river shoes when you stop. Also, the grand view of spectacular canyons may be missed with this method because you are floating on your stomach so enthralled in the flora and fauna of the river that you are oblivious to the world above.

Thirdly is kayaking, which I have yet try. There were quite a few that passed us by as our tube caravan stalled in the still water and we frantically paddled our arms over the inflated tube to continue our journey. This makes floating the river a not- so- time-consuming event. Our trip on tubes took over five hours, and I assume the kayakers did it in half the time. This method allows you to enjoy the trip at a pace that you can control and also take time to marvel at the wonders of God's creation without suffering severe sunburn, being exposed on a tube for hours in the sun.

Most trips to the Frio River cannot be done as a day trip so accommodations can be made by logging on to the internet to secure a place to spend the night. This should be done well in advance as there limited cabins in the area and they get booked early.

Regardless of which method you take, you will undoubtedly be exposed to the unsightly litter that distracts from the natural beauty that surrounds you. I was amazed to see the tremendous amount of trash in the river itself as well as on the

banks. To me this exhibits a blatant disrespect for the beauty of our State. It was really disheartening to see these discarded items, beverage cans and bottles at every turn in the river. Sure, some may be the result of an inadvertent loss of an item but when you see a group of ten to fifteen empty beer cans plied up among the rocks there can be no doubt that it was a deliberate act. At one rope swing hanging from a tree, I had to pick my way through discarded beer cans to get to the rope.

Surely if someone is floating down the river with a six pack or more, as was obvious from the stacks I saw, there is undoubtedly an ice chest to keep them cool. This ice chest can be used as a receptacle for the used cans, bottles, food wrappers and other assorted trash. Just take an extra plastic grocery bag to place the used items in and place the bag in the ices chest. To conserve space, the cans can be smashed into small discs with the aid of the many rocks that are everywhere. When you arrive at your final destination simply place the trash in a trash bin or take it back to your campsite and dispose of it there.

Whenever we go to a public place to enjoy the great outdoors, I always take pride in leaving the place cleaner than when I arrived. Before leaving the whole family joins in a final clean up of our area of responsibility. Even trash left by others is gathered and disposed of properly. It takes just a small amount of time and effort but it is well worth the feeling of preserving our wild areas. We can all help keeping the Great State of Texas clean, please do your part and DON'T MESS WITH TEXAS!

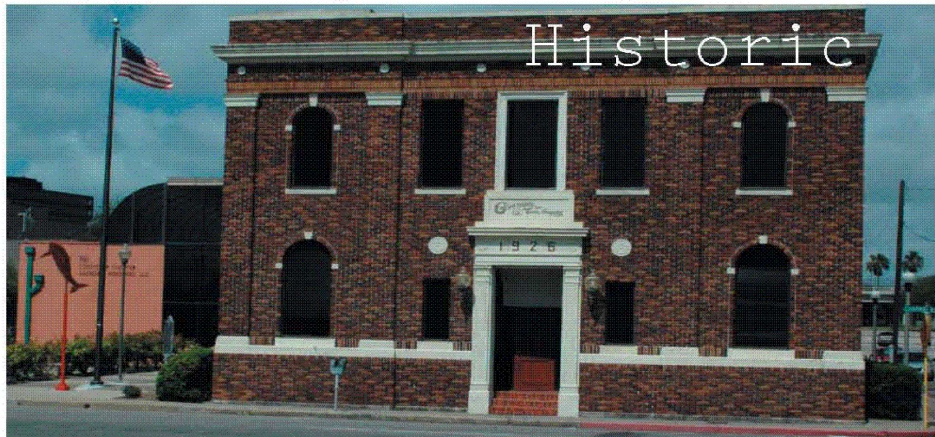

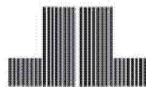
