Texas Law Enforcement Launches No-Refusal July 4th

Texas law enforcement won't be taking no for an answer this Fourth of July, particularly from motorists driving drunk and refusing to cooperate when stopped.

Officers, judges and district attorneys will be doubling down on law enforcement in conjunction with a "No Refusal" campaign launched just in time for the holiday festivities. The National Highway Traffic Safety Administration reports that the July 4th holiday ranks No. 1 nationally for alcohol-related fatal crashes. In 2011, Texas saw 308 alcohol-related crashes during the holiday.

The Texas Department of Transportation's (TxDOT) outreach program puts a new face on the the agency's "Faces of Drunk Driving" campaign—a statewide initiative that garnered national and international attention with the story of Jacqui Saburido, the young woman whose face was burned beyond recognition after being hit by a drunk driver.

This year's campaign highlights Sean Carter who suffered a massive brain injury when a car in which he was riding spun out of control and slammed into a tree. Both Sean and the driver were legally drunk.

"July Fourth is the deadliest holiday of the year for alcohol-related crashes in the United States," said Carol Rawson, TxDOT's Traffic Operations Division director. "Texans need to hear Sean's powerful story and know that law enforcement will be out in force. It's important to make the right choices. Stay safe and enjoy the holiday. If a celebration involves alcohol, don't drive."

"No Refusal" means just that. Motorists suspected of driving while intoxicated must provide a breath or blood sample to law enforcement. Should they refuse to comply, law enforcement officials can take the suspect to jail, where a judge then signs an expedited search warrant that calls for a mandatory blood sample to be taken by a qualified health-care professional. Those found to be legally intoxicated (i.e., with a blood or breath alcohol content of .08 or higher) are arrested and prosecuted.

"This is not new to Texas," said Montgomery County Assistant District Attorney Warren Diepraam. "Officials have seen a significant drop in DWI activity in areas of the state where these programs have been used. In Montgomery County, we have seen a big drop in intoxication manslaughter charges since we started our no-refusal program."

Still, more than 1,000 Texans are killed each year as a result of impaired drivers, and Texas is frequently ranked as the nation's deadliest for impaired driving deaths. In 2011, Texas saw 24,151 alcohol-related crashes, resulting in the loss of 1,038 lives.

To drive home this message, TxDOT has updated its "Faces of Drunk Driving website with a new story that illustrates the human impact of drunk driving. Sean Carter was a 22-year-old college junior, out having drinks with friends. Sean knew he was in no condition to drive home, but neither was the friend who gave him a ride. The driver walked away from the same crash that left Sean in a wheelchair and unable to talk. Sean now uses a computer to speak.

"Don't drink and drive, and please don't make my mistake of riding with someone who has been drinking," Carter said. "If I knew then that the decisions I would make on that night a few years ago would affect the rest of my life, putting me here in this wheelchair unable to walk or talk, you can bet I would not have done what I did."

**Statement from Texas
Comptroller Susan Combs on
the Supreme Court's Decision
to Uphold the Patient
Protection and Affordable
Care Act:**

"I am very disappointed with the Supreme Court's decision to uphold the Patient Protection and Affordable Care Act. It is a bad law and bad policy. The mandate to purchase individual health insurance through a brand new tax is an attack on personal liberty. This law is a reminder of President Ronald Reagan's warning from a quarter century ago when he said, 'Government's view of the economy could be summed up in a few short phrases: If it moves, tax it. If it keeps moving, regulate it. And if it stops moving, subsidize it.'

"In addition, the law will place an enormous burden on Texas taxpayers and place a huge constraint on our budget. The Supreme Court has left open the possibility that states could opt out of Medicaid expansion without losing money for the existing Medicaid program. Opting out to slow the projected growth of Medicaid is something the Legislature may have to consider once we've had time to further assess this decision."

**CORNYN DELIVERS FLOOR SPEECH ON
HEALTH CARE DECISION**

U.S. Sen. John Cornyn (R-TX) today delivered the following remarks on the Supreme Court's decision regarding President Obama's health care law:

Excerpts from Sen. Cornyn's remarks:

"This morning's decision by the United States Supreme Court has clarified some things. It has made other things more muddled. What it has clarified is the importance of the upcoming election on November 6, 2012. The only way to stop the overreaching by the federal government, including the president's flawed health care bill, is to elect a new president and a Congress that will repeal and replace this fundamentally flawed law.

"Before the health care bill became law, the president repeatedly assured the American people that he would not raise taxes on the middle class. He declared emphatically that the individual mandate was 'absolutely not a tax increase.'

"But the Supreme Court of the United States has made absolutely clear that the only way Obamacare can be upheld as within the constitutional power of congress is for it to be considered a tax increase and a tax increase on every single American, regardless of income.

"The president also told us his health care law would reduce premiums by \$2,500 for the average family. That was another broken promise. Last year the average American family with employer-sponsored insurance saw their premiums rise by \$1,200.

"The case against this health care legislation is very simple. It relies on massive tax increases, job-killing regulations, and government coercion. It will place Washington bureaucrats between patients and their doctors, and it will cause millions of Americans to lose their current insurance coverage."

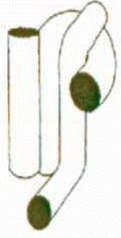
