What: The CCSO presents the third subscription concert of its 67th consecutive season with its annual event that has become a popular family holiday tradition.

The CCSO and featured sopranos Hsin Yi Lin and Vanessa Becerra will be joined by more than 170 voices from area choirs as well as 10 year old Julliard trained and international rising star Elli Choi, violin. The Corpus Christi Chorale, directed by Dr. Ross Bernhardt, the Del Mar Master Chorus, directed by Dennis Richardson, and the Del Mar Children's Chorus, directed by Ouida Bliss Richardson will join the CCSO in a special collaboration of holiday favorites, symphonic classics, and the ever-popular audience sing-a-long.

About the Corpus Christi Symphony Orchestra

The Corpus Christi Symphony Orchestra, now in its sixty-seventh consecutive season, is the premiere symphonic orchestra along the Texas Gulf Coast. Grammy®-nominated Music Director and Conductor John Giordano, formerly Music Director and Conductor with the Fort Worth Symphony Orchestra for 28 seasons, is in his ninth full season with the orchestra.

Giordano's and the CCSO's reputations for high-quality performances have resulted in appearances with some of the best known artists of our day. Over the last several seasons, guest artists have included Van Cliburn, Itzhak Perlman, Andre Watts, Sarah Chang, Yefim Bronfman, Marvin Hamlisch, Joshua Bell, the Romeros, Evelyn Glennie, Barry Douglas, Frederica von Stade and Nobuyuki Tsujii.

The 2012-2013 season includes our traditional six subscription concerts with two special event pops concerts, A Tribute to the Beatles and Pops in the Park, added this season. In addition to its regular season concerts, the orchestra performs educational concerts for area school children each year. The CCSO also manages and supports more than 100 students in the Corpus Christi Area Youth Orchestra.

The CCSO's principal performance venue is the acclaimed 1,400 seat Performing Arts Center (PAC) at Texas A&M University-Corpus Christi. Celebrating its seventh anniversary in 2012, the PAC was constructed at a cost of \$18 million and features superb acoustics for live performances. The orchestra is also supported by the Symphony Guild of Corpus Christi.

State of Texas Wins National Cybersecurity Award Texas Department of Information Resources Named **Tops in Cybersecurity Leadership & Innovation**

The winners of the 2012 Cybersecurity Leadership & Innovation Awards were announced last evening. The awards program — hosted by the Center for Digital Government, the research and advisory arm of Government Technology's parent company, and underwritten by McAfee — recognizes government and education agencies for their efforts in the field of cybersecurity technology services. The award recipients, which were chosen by an evaluation committee, were recognized during an awards dinner and ceremony at the annual McAfee FOCUS conference on Tuesday, Oct. 23. The Texas Department of Information Resources (DIR) was named the Leadership and Innovation winner in the State Government Category. "As CIO for the State of Texas and Executive Director of DIR, I am extremely proud of the DIR team and their accomplishments," said Karen Robinson. "The positive feedback we receive from other state agencies confirms what this award has recognized—Cybersecurity is one of the top priorities of our state."When asked to highlight what cybersecurity efforts contributed to winning the award, John Hoffman, DIR's Director of Communications Technology Services Division, commented, "Our migration to a Security Event and Threat Analysis (SETA), cloud-based platform has allowed 24-hour/seven-day-a-week security monitoring. While DIR is grateful for this award, the program has been a team effort, from executive sponsorship, state agency participation, and our vendor partner, AT&T. Our goals going forward include expanding the SETA outreach to other entities, and continuing our research into customer needs and helping them meet their challenges in a safe and secure environment." The other Cybersecurity Leadership & Innovation Award winners announced include: NYC Department of Information Technology & Telecommunications - City Government Category Georgia State University - Education Category City of Tampa Technology & Innovation Information Security Office - Special Award Seattle Metropolitan Area - Collaboration Award Corey Cush, AVP Infrastructure Services, NYC Health and Hospitals Corp. – Leadership Award.
